I give, devise and bequeath all of my property, be the same real or personal and wherever situated, to my children and to the descendants of any that now have or shall precede me in death in equal shares, to have and to hold forever. The share of the descendants of any deceased child or children shall be that to which the parent would have taken if living.

I hereby nominate and appoint my son-in-law, Windsor B. Harris, Executor of this, my last will and testament.
